The Sweepstakes is subject to all applicable federal, state and local laws and regulations and is void where prohibited or otherwise restricted by law. 2. SWEEPSTAKES TIMING. The Sweepstakes begins at 12:00:00 p.m. Pacific Time (“PT”) on October 29, 2021 and ends at 11:59:59 p.m. PT on November 12, 2021 (“Sweepstakes Period”). The computer administering the Sweepstakes is the official time-keeping device for this Sweepstakes.

3. HOW TO ENTER. During the Sweepstakes Period, visit aa.com/RamsUnderTheLights (“Website”) and follow the instructions to complete and submit an online entry form. **Limit one (1) entry per person per day, regardless of the email address used.** A “day” is defined as the twenty-four (24) hours between 12:00:00 a.m. PT and 11:59:59 p.m. PT of the same day with the exception of the first day of the Sweepstakes Period which shall begin at 12:00:00 p.m. PT and end at 11:59:59 p.m. PT of the same day.

Incomplete or ineligible entries will not be acknowledged. All entries become the exclusive property of Sponsor and will not be returned or acknowledged except as provided herein. Each entry must be manually keystroked or entered by the individual entrant. Multiple entrants may not share the same email address. A potential winner may be requested to provide Sponsor with proof that he/she is the authorized account holder of the email address associated with the winning entry and/or an eligible entrant.

Four (4) prizes will be awarded, each consisting of an American Airlines “Exclusive Los Angeles Rams Experience” for winner and winner’s one (1) guest at the American Airlines Plaza at SoFi Stadium (the “Event”). The Event will take place with the other Sweepstakes winners and their guests consisting of food, beverages, and a meet and greet with NFL talent (as selected by the Rams in their sole discretion). Exact date and time to be determined at a later date by the Rams and Sponsor, in their sole discretion, and is subject to change. The Event date will be communicated to the potential winners at the time of notification or shortly thereafter once determined. If air transportation and hotel accommodations are deemed necessary in order to attend the Event (in Sponsor’s sole discretion), the winner will also receive round-trip coach air transportation (from a major airport servicing American Airlines nearest winner’s home) for winner and winner’s one (1) guest and standard, double-occupancy hotel accommodations (one room) for one (1) night. **Ground transportation, upgrades, meals, gratuities, luggage fees and all other expenses not specified herein are solely the winner’s responsibility.** Approximate Retail Value (“ARV”) of prize if attending the Event (without air and hotel): \$500.00. All federal, state and local taxes and any other costs and expenses associated with the acceptance and/or use of prize; including those not specifically provided for in these Official Rules are solely a winner's responsibility. In the event that the claimant is able to demonstrate that the costs of arbitration will be prohibitive as compared to the costs of litigation, Sponsor will pay as much of the claimant's filing and hearing fees in connection with the arbitration as the arbitrator deems necessary to prevent the arbitration from being cost-prohibitive. If any part of this arbitration provision is deemed to be invalid, unenforceable or illegal (other than that claims will not be arbitrated on a class or representative basis), or otherwise conflicts with the rules and procedures established by JAMS, then the balance of this arbitration provision shall remain in effect and shall be construed in accordance with its terms as if the invalid, unenforceable, illegal or conflicting provision were not contained herein. If, however, the portion that is deemed invalid, unenforceable or illegal is that claims will not be arbitrated on a class or representative basis, then the entirety of this arbitration provision shall be null and void, and neither claimant nor Sponsor nor any Released Parties shall be entitled to arbitrate their dispute. Upon filing a demand for arbitration, all parties to such arbitration shall have the right of discovery, which discovery shall be completed within sixty days after the demand for arbitration is made, unless further extended by mutual agreement of the parties. **THE ARBITRATION OF DISPUTES PURSUANT TO THIS PARAGRAPH SHALL BE IN THE ENTRANT'S INDIVIDUAL CAPACITY AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PURPORTED CLASS OR REPRESENTATIVE PROCEEDING.
